

## **Official Contest Rules**

Bimose Tribal Council (BTC) is hosting a Logo Contest for it's Jordan's Principle Regional Hub department on the @bimosetribalcouncil Facebook and its website, bimose.ca. This Logo Contest will comply with any platform-specific rules.

There is no purchase necessary to enter for win. As a non-profit, BTC does not have products and services that are available for the public to purchase.

- 1. **Eligibility:** The Logo Contest (the "Contest") are open only to those who follow the guidelines on the specific social media post (the "Post") and who are 13 years of age at the date of entry. The Contest is only open to Canadian residents. Entrants are only eligible to win once. Employees of BTC (their "Sponsor"), subsidiaries, advertising and promotion agencies, suppliers, and their immediate family members, and/or those living in the same household of each are not eligible to participate in the Contest. Contest are subject to all applicable federal, state, and local laws and regulations. Void where prohibited.
- 2. **Agreement to Rules:** By participating, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. You agree to submit artwork that is only your own and nothing by others or under copyright. In addition, you agree to accept the decisions of BTC's choice of winners as final and binding as it relates to the content. The Contest is subject to all applicable federal, state and local laws.
- 3. **Contest Period:** The Contest launches on Tuesday, December 6/22 and closes entries on Friday, January 20/23. All times listed are for the CST timezone in Kenora, Ontario, Canada. Winners will be contacted Wednesday, January 23/23.
- 4. How to Enter: (1) Like and Follow @bimosetribalcouncil on Facebook. (2) artwork submission for the Contest may be entered by e-mailing jordans.principle@bimose.ca before the Contest close period with the subject line "Bimose Jordan's Principle Logo Contest [Your Name]". Entries that are not complete or do not adhere to the Rules or specifications outlined in the Submission Checklist may be disqualified at the sole discretion of BTC. Each email submission will be counted as a separate entry. If you use fraudulent methods or otherwise attempt to circumvent the rules your submission may be removed from eligibility at the sole discretion of BTC.
- 5. **Prizes:** There will be three (3) winners and prize packages. Prizes are as follows:
  - (1st Place): Apple iPad mini 8.3" 64GB with Wi-Fi (6th Generation) & Beats by Dr. Dre Solo3 On-Ear Sound Isolating Bluetooth Headphones.
  - (2<sup>nd</sup> Place): \$250 VISA gift card
  - (3<sup>rd</sup> Place): \$150 VISA gift card



No cash or other prize substitution permitted except at BTC's discretion. Cost of the prize and to ship to the winners are at the expense of BTC. BTC is not responsible for any lost mail. Acceptance of the prize constitutes permission for BTC to use the winner's artwork and design files for purposes of advertising and promoting BTC. BTC may also announce the winners' names online. BTC may use the same artwork and/or adjust colours, designs, and use winning submissions as concept art to base the final Bimose Jordan's Principle Regional Hub logo.

6. Winner selection and notification: Winners of the Contest will be selected The winners will be selected by a panel of up to six (6) judges consisting of a combination of BTC staff, Elders in the community, and members from our Board of Directors. Winners will be notified via e-mail or phone with the contact information provided when they entered the Contest. BTC shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail, no voicemail, or other settings or for winners' provision of incorrect or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 3 days from the time award notification was sent, or fails to timely return of Artwork Release Waiver as required, prize may be forfeited and an alternate winner selected.

The receipt by winner of the prize offered in this Contest is conditioned upon compliance with these Official Contest Rules. ANY VIOLATION OF THESE OFFICIAL RULES BY ANY WINNER WILL RESULT IN SUCH WINNER'S DISQUALIFICATION AS WINNER OF THE CONTEST AND ALL PRIVILEGES AS WINNER WILL BE IMMEDIATELY TERMINATED.

- 8. **Rights Granted by you:** By entering this content you understand that BTC, or anyone acting on behalf of BTC, or its respective licensees, successors and assigns will have the right, where permitted by law, without any further notice, review or consent to use your artwork (including concept art) in print, publish, broadcast, distribute, and use for advertising, public relations and promotional purposes without any further compensation.

Terms: BTC reserves the right, in its sole discretion to cancel, terminate, modify or suspend the Contest should (in its sole discretion) a virus, bugs, non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Contest. In such case, BTC may select the recipients from all eligible entries received prior to and/or after (if appropriate) the action taken by BTC. BTC reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Sweepstakes or website or violates these Terms & Conditions.
